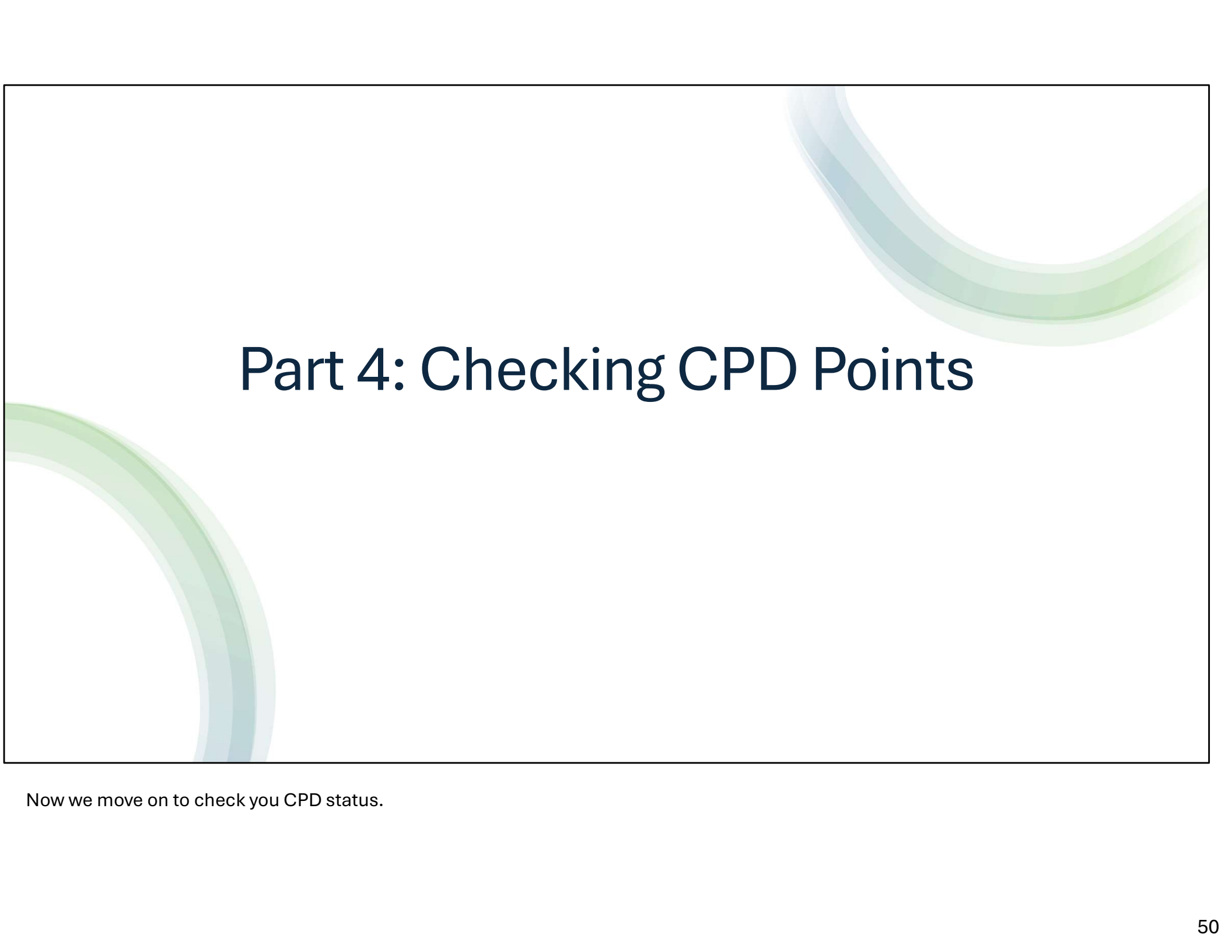


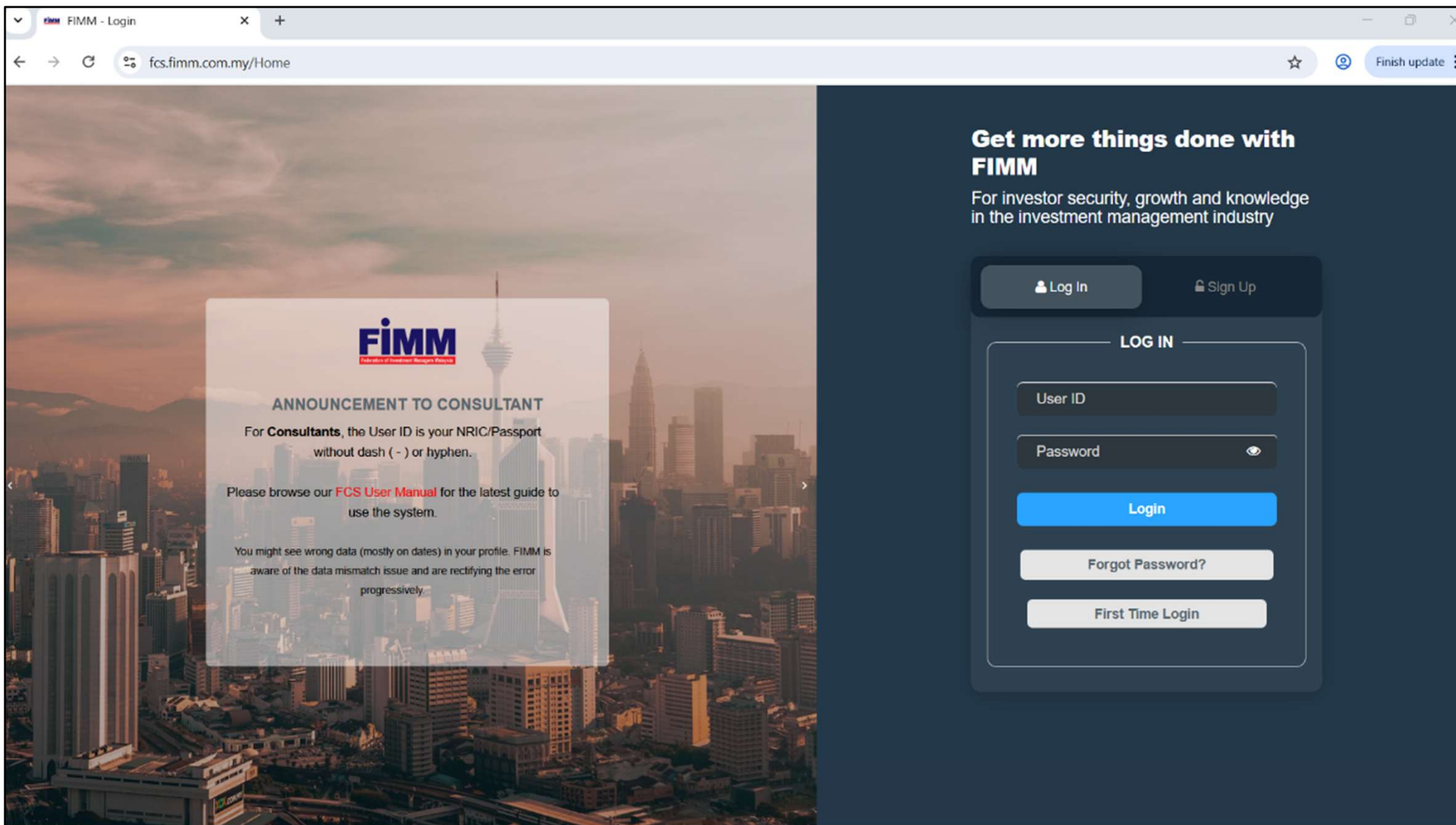


Part 4: Checking CPD Points

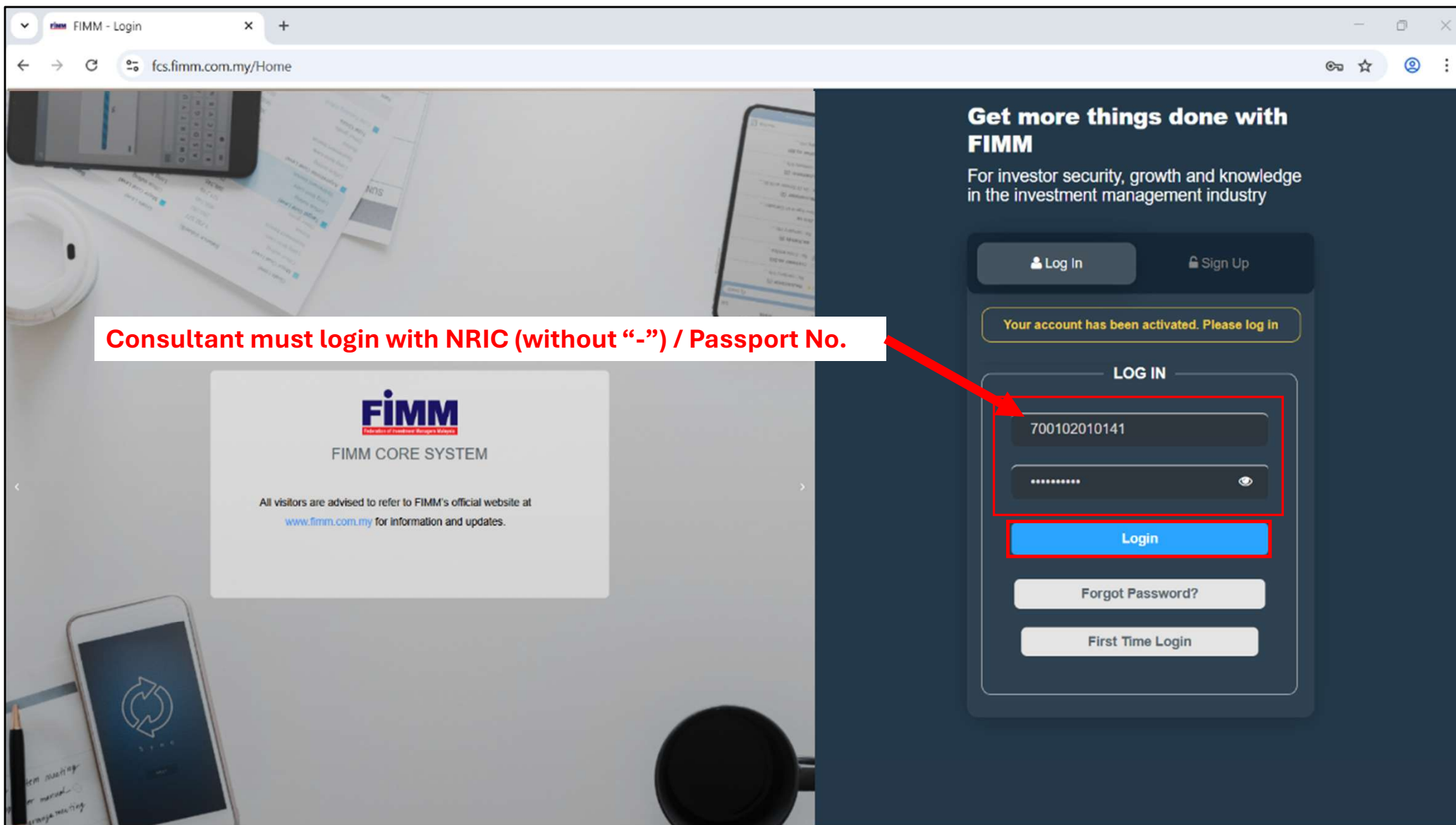
