- 4. Minimum number of participants required for each Members/Distributors' session is 30 pax.
- 5. Principals may register your Consultants for the training by completing the relevant Registration Form and return it to FIMM.
- 6. Consultants who have attended COE training in 2019 & 2020 are not allowed to be registered.
