FIMM EXAMINATION: ADDITIONAL EXAMINATION SESSIONS FOR MIRI, SARAWAK

1.0 Additional Examination Sessions

- 1.1 Further to FIMM's circular PDS/AL/KOH-SNZ-ms/031-20 dated 5 October 2020, FIMM is pleased to announce the additional examination sessions for Miri, Sarawak. Please refer to the attached **Appendix 1** for further details.
- 1.2 These new examination sessions are added to cater for the promising demand for FIMM examination seats in the month of November 2020.

2.0 Enhanced Examination Standard Operating Procedures (ESOP)

- 2.1 ESOP will be enforced in all exam centres. All candidates are required to observe the following ESOP before, during and after attending the FIMM Examinations:
 - a) Candidates must wear face mask and are free from any symptom of fever and flu <u>before</u> they are allowed to enter the premise of the FIMM Examination Centre; and
 - b) Once in the FIMM Examination Centre, candidates must maintain social distancing at all times, taking measurement on body temperature, use hand sanitizer and observe other relevant safety measures as prescribed by the National Security Council (MKN) and directed by the Examination Site Coordinator (ESC).
