### FIMM EXAMINATION CENTRE RE-OPENING AND INTRODUCTION OF NEW MELAKA EXAMINATION CENTRE

#### 1.0 Re-Opening and Introduction of New Melaka Examination Centre

1.1 Further to FIMM's circular PDS/AL/KOH-SNZ-ms/014-20 dated 18 June 2020, FIMM is pleased to announce the re-opening of FIMM Examination centre in Melaka.

1.2 FIMM Examinations will be resumed at new examination centre (Manipal Medical College) starting 8 August 2020. Please refer to the attached **Appendices 1 and 2** for details on examination dates as well as the new examination centre.

#### 2.0 Enhanced Examination Standard Operating Procedures (ESOP)

2.1 Similar to other FIMM Examination centres, ESOP will be enforced in Melaka examination centre. All candidates are required to observe the following ESOP before, during and after attending the FIMM Examinations:

- a) Candidates must wear face mask and are free from any symptom of fever and flu **before** they are allowed to enter the premise of the FIMM Examination Centre; and
- b) Once in the FIMM Examination Centre, candidates must maintain social distancing at all times, taking measurement on body temperature, use hand sanitizer and observe other relevant safety measures as prescribed

by the National Security Council (MKN) and directed by the Examination Site Coordinator (ESC).

2.2 Failure to comply with any of the above safety measures will be reported to FIMM. Such actions may render the candidates' results to be void or examination session to be terminated.
