Registration of Private Retirement Scheme (PRS) Provider, Institutional Private Retirement Scheme (PRS) Adviser or Corporate Private Retirement Scheme (PRS) Adviser and Private Retirement Scheme (PRS) Consultant

Guidelines on Registration of Private Retirement Scheme Distributors and Consultants ("Guidelines") has been approved by Securities Commission (SC) and came into effect on 29 June 2012. The Guidelines is now available at FIMM's website.

Pursuant to the Guidelines, any person who wishes to market or distribute as PRS Provider / Institutional PRS Adviser / Corporate PRS Adviser, is required to register with FIMM. If you have obtained approval from SC for new PRS / fund, notification must be submitted to FIMM at least three (3) business days before the launch date of the PRS / fund. Documents to be submitted consist of:

- a) A copy of approval letter from the SC for new PRS/fund (including core funds); and
- b) Two (2) sets of product highlight sheet and disclosure document
- Key data section of the disclosure document duly registered with the SC.

In the event that the printed product highlight sheet and disclosure document are not available at the point of notification, PRS Provider may provide a copy of the key data section of the disclosure document duly registered with the SC. The printed product highlight sheet and disclosure document must subsequently reach FIMM within a week after the launch of the PRS/fimd.

Application for registration as PRS Consultant must be made through respective PRS Provider / Institutional PRS Adviser / Corporate PRS Adviser. Please download the Application Kit for the relevant forms. The following persons are exempted from sitting for the PRS Examination: (a) Unit Trust Consultants (UTC) who:-

have, as at 31 July 2012, at least three (3) years experience as UTC;

do not have any adverse record;

iii) have, by 30 June 2013, attended the Private Retirement Scheme familiarization program conducted by trainers who are certified by the Securities Industry Development Corporation / SC and registered with FIMM; and

 have proof of their attendance to the Private Retirement Scheme familiarization program for the purpose of registration with FIMM, which is valid until 31 July 2014.

In the event that the syllabus of the qualifications under nem (2)(c) of Appendix A under the Guidelines are not enhanced to include private retirement scheme by 30 June 2014, FIMM may require holders of such qualifications to sit for the PRS Examinations.
