He has over the years been a trainer for most of the insurance companies and the middle management of Maybank , MBF Insurance and MAAKL.



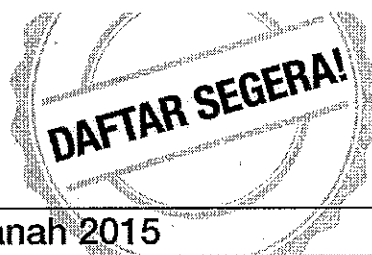
