ENHANCEMENT TO THE ELEKTRONIK PILIHAN PELABURAN AHLI (e-PPA) SYSTEM

1.0 Introduction

- 1.1 The Employees Provident Fund (EPF) is currently enhancing the e-PPA system to make EPF members' mobile phone numbers mandatory information.
- 1.2 Withdrawal applications with incomplete or invalid mobile phone numbers will be rejected by EPF. Hence, there will be new rejection codes for incomplete and invalid numbers, respectively.
- 1.3 Rexit Software Sdn Bhd (REXIT), the third-party administrator, has incorporated the enhancement into the e-PPA Data Integration Specifications version 2.4.2. A copy of the specifications document is enclosed with this circular for your perusal.
- 1.4 The enhancement is expected to go live in mid-May 2024. Further details will be provided upon confirmation from EPF.

2.0 Actions Needed by FIMM

- 2.1 FIMM and REXIT will be conducting a briefing to discuss necessary changes and/or gather industry feedback.

3.0 Actions Required by EPF

- 3.1 While waiting for the system enhancement to be completed, all IPDs (and the Consultants) are required to ensure EPF members fill in valid mobile phone numbers in the KWSP 9N Form.
- 3.2 This step is to facilitate a smooth transition towards the mandatory inclusion of mobile phone numbers.
