### **Introduction of FIMM Combined Examination (FCE) and Exam Schedule for May and June 2025**

1. Following the recent launch of the FIMM Core System (FCS), FIMM is pleased to introduce the FIMM Combined Examination (FCE), enabling individual applicants to register as both Unit Trust (UTS) and Private Retirement Schemes (PRS) consultants through a single examination sitting.
2. The key features of the FCE are as follows:
  - i) Duration of exam : 120 minutes (2 hours)
  - ii) Number of questions : 60 questions
  - iii) Passing Marks/Threshold : 75% (45 correct answers)
3. All applicants must adhere to the following:
  - i) Must self-register as a candidate via FCS;
  - ii) Exam seat availability is based on a first-come, first-serve basis;
  - iii) Rescheduling must be performed via FCS before the exam registration closing date;
  - iv) No rescheduling is permitted after the exam registration closing date; and
  - v) Failure to attend the registered exam session will be treated as an absence.
