FIMM Combined Examination (FCE) Schedule for July, August and September 2025

- Following the recent launch FIMM Combined Examination (FCE) in May 2025, FIMM is pleased like to announce the examination dates scheduled from July to September 2025.
- 2. The FCE structure are as follows:

i) Duration of exam : 120 minutes (2 hours)

ii) Number of questions : 60 questionsiii) Type of questions : Multiple choice

iv) Passing Marks : 75%

v) Reference : FIMM Combined Examination Study Guide

(English/Bahasa Malaysia)

- 3. All applicants must adhere to the following:
 - i) Must self-register as a candidate via FCS;
 - ii) Exam seat availability is based on a first-come, first-serve basis;
 - iii) The last day to reschedule the examination session is three (3) business days prior to the scheduled exam date, and must be performed via FCS;
 - iv) Rescheduling is not permitted after the exam registration closing date; and
 - v) Failure to attend the registered exam session will be treated as an absence.
